As a key contributor to HEQCO's work, you will collaborate with the Vice President, Research and Policy to shape research priorities. Your expertise in policy analysis, research design, and report writing will play a crucial role in guiding the organization's initiatives. If you are passionate about public policy and enhancing access, quality and accountability for Ontario's colleges and universities, you are encouraged to explore this exciting opportunity.

In this pivotal position, your duties will include:

- Acting as a secondary support on HEQCO projects to enhance the development of policyrelated implications and recommendations.
- Providing direction, mentorship and guidance to Senior Researchers, Researchers and Interns in the development of policy related implications and options for HEQCO products, including policy-focused research projects, blogs, and presentations.
- Conducting reviews of current policy initiatives underway in government and following the status of upcoming policy changes within the legislature.
- Developing and maintaining (or leveraging existing) partnerships with key stakeholders including leaders in the sector, government officials and others on a national and international level to facilitate HEQCO research priorities, articulate policy alternatives, and facilitate collaboration and innovation.
- Representing HEQCO publicly and mobilizing HEQCO's research by presenting and participating atconferences, events, on advisory committees and in other relevant contexts.
- Working with the Director, Communications on solutions and opportunities to maximize impact of HEQCO's publications and to build readership through multiple channels.



The ideal candidate should have:

- Master's degree in public policy, higher education, educational research or related field.
- Proven and demonstrated experience leading and developing policy options and projects leading within the public and/or postsecondary sector (preferred) and providing analyses and advice to inform policy and innovative system changes.
- Knowledge of methodologies and techniques to motivate, lead and execute multiple shortand long-term projects.
- Project management skills to manage multiple, concurrent projects within timelines.
- Conceptual, analytical and problem-solving skills.
- Government and sector engagement skills to develop and maintain relationships with key stakeholders in order to facilitate collaboration and policy option generation.
- Written communication skills to write and edit expert research publications, evaluation reports, and other related materials.
- Experience with qualitative and/or quantitative research design and execution.
- Experience with policy analysis.
- Experience working within government as part of the policy division of a provincial ministry which cultivates partnerships with internal and external stakeholders considered an asset.
