Mandate

We do this as a vital partner and convener of the postsecondary education and training sectors, maximizing opportunities for institutional collaboration to create academic pathways, facilitating recognition of prior learning and supporting learners transitions and entry into the labour market.

ONCAT's core activities

- **operating ONTransfer.ca**, a guide that helps learners explore their transfer and pathway options
- **supporting projects** to develop innovative practices that can be replicated across institutions
- **engaging with learners** to raise awareness about learner mobility and improve their understanding of transfer and pathway opportunities
- **driving system efficiencies** through the development and adoption of shared tools and evidence-based practices



Measuring Learner Mobility

5% of postsecondary students in Ontario were marked with a Credit Transfer Flag in 2023–24

12% of postsecondary students in Ontario graduated from an institution that is different than their first one (2009–16 cohorts)

14% of incoming (2024) postsecondary students in Ontario planned to apply for transfer credits

48% of incoming (2024) postsecondary students in Ontario had previous postsecondary experience

32% of domestic applicants had previous postsecondary experience.

Developed with the BC Council on Admissions & Transfer, Ontario Transfer Credit System (ONTCS) is an all-in-one platform for transfer credit management.

- free for ONCAT member institutions, eliminating licensing or subscription costs
- replaces manual processes (spreadsheets, emails) or custom-made systems that are expensive to maintain or inconsistent across sector



Developed in partnership with Lakehead University, PathwAI uses AI to compare learning outcomes across programs at different institutions, streamlining course and program assessments.

ONCAT-funded projects — learner mobility

Building Partnerships to Support Learner Mobility

Establishes a structured system to support learners transferring from Indigenous Institutes to universities, creating more opportunities for learner mobility.

Bridging Programs to Bolster Student Success

Develops a bridging program — specifically for transfer students — that supports both academic success and social integration.

Engineering Pathways for Military-Connected Learners

Recognizes the skills and experiences from the Canadian Armed Forces to create specialized pathways for military-connected learners to enrol in accredited Bachelor of Engineering programs.

ONCAT-funded projects — learner mobility

Transfer Pathways to Engineering Programs

Expands the participation of more institutions to a successful transfer pathway between engineering technology college diplomas and accredited engineering university degrees.

Kinesiology-to-Paramedic Transfer Pathway

Develops a university-to-college transfer pathway that reduces the time and cost for graduates with a kinesiology degree to earn an additional credential as a paramedic.

ONCAT-funded projects — PLAR

PLAR for Early Childhood Education

Improves the efficiency of PLAR processes for a college ECE program, awarding credit for the professional experiences of learners and accelerating their completion of a credential that will broaden their employment opportunities.

Exploring AI-Powered Tools for PLAR

Evaluates the viability of using AI-powered tools to enhance the efficiency and quality of PLAR assessment activities.

Embracing A Two-Eyed Seeing Approach to PLAR

By creating culturally relevant assessment practices for admission, the project will increase opportunities for Indigenous learners to access postsecondary programs.

ONCAT Principles of Learner Mobility

Learners have a right to:

- clear, accurate information about learner mobility via ONTransfer.ca
- avoid repeating learning they've already mastered
- receive credit unless substantial differences exist
- fair, predictable and timely transfer credit decisions
- a clear rationale if transfer credit or prior learning is denied
